We arrange accident and liability insurance for the Scouts to protect its members

We arrange insurance on behalf of the Scouts which covers accidents and injuries to members and liabilities of volunteers and trustees. This includes.

As part of this, we liaise with the Scouts Program and Development team to ensure that there is suitable insurance in place for members whenever new activities are introduced.

Checking indemnity agreements and issuing Public Liability Certificates

If you use a facility belonging to another organisation or individual, you may be required to sign an agreement or indemnity and provide proof of public liability insurance. We'll check any agreement being signed with you and provide the necessary insurance certificates.

Insurance cover specifically designed and developed for Scout Groups, Districts and Counties

Not all of your Scout insurance needs are covered under The Scout's insurance policies and you may need to take out additional cover for your own Scout Group, District or County.

We provide a full range of additional specialist insurance policies which you can purchase from us and we're here to help you decide which are appropriate.
